The Ridge Live Steamers are the delighted recipients of Stan Wells’ donation of his entire Santa Fe “War Bonnet” train. Complete with two car carriers, two “T-bar” riding cars, Engineer’s riding car, Conductor’s riding car and Caboose. This train will be used exclusively for conducting visitors on a tour of the railroad and in card order sessions. The engine is a GE Dash 8 – 40GW built by Duncan Herring. Because of some unique features of the engine engineers will need to be “checked out” in the proper operation of the engine. In addition the train came complete with storage/transportation racks, a portable hydraulic lift, all the track and switches. The Ridge Live Steamers are indebted to Stan for this fantastic donation.



Ridge held its second Ops Session of the year on January 21st. Good weather was with us on Saturday but wind and threat of rain curtailed operations on Sunday.

Terms and Conditions

1. Items brought for sale on consignment should be railroad or hobby related.
2. The Yard Sale manager has the right to refuse to accept any donated or consignment item for any reason.
3. If you bring an item to sell on consignment, 10% of the selling price or \$1.00 (whichever is greater) will be retained by RLS as commission.
4. You may donate an item for sale. 100% of the sale price goes to RLS.
5. You must establish a suggested selling price for any donated or consignment items. You may indicate a minimum selling price for consignment items.
6. Any consignment items not sold must be picked up by the consignor as soon as possible at the end of the sale. RLS will not be responsible for items remaining beyond the close of the sale.
7. Consignment items may be brought to the Yard Sale location no earlier than 9:00 a.m. on Friday of the meet. Unsold items must be picked up by the consignor no later than 4:00 p.m. on Saturday. RLS will not be responsible for any items brought in prior to the start of the sale on Friday nor items left after the close of the sale on Saturday.
8. The Switch Yard Sale will be open from 10:00 a.m. to 4:00 p.m. on Friday and from 10:00 a.m. to 3:30 p.m. on Saturday.
